## Quick look...

- > The budget provides GRF subsidies to 13 veterans' organizations.
- > The subsidies total \$2.5 million in FY 2022 and FY 2023, an increase of 49.6% from FY 2021.

## Analysis of FY 2022-FY 2023 budget

The budget provides \$2.5 million in FY 2022 and FY 2023 in General Revenue Fund (GRF) subsidies to 13 different organizations that serve Ohio's veterans. The 21.4% decrease from FY 2020 to FY 2021 shown in the above table reflects FY 2021 expenditure reductions ordered by the Governor, as state tax receipts were lagging due to declining economic activity caused by the COVID-19 pandemic.

The primary mission of the veterans' organizations is to promote and assist veterans of their particular community. These groups provide services to veterans and their families to help assist with accessing benefits, job placement and training, transportation to and from Veterans Affairs (VA) medical facilities, and emergency assistance.

In addition to these state GRF subsidies, each organization receives funding through federal grants, membership dues, fundraising efforts, and private donations. These subsidies primarily are used to pay salaries and wages for service officers, transportation and meeting expenses, as well as other operating expenses. These organizations are required to annually report to the Director of Veterans Services.<sup>1</sup>

The budget contains a temporary law provision requiring the Department of Veterans Services to use GRF line item 900408, Department of Veterans Services, to pay veterans' organizations' rent in buildings managed by the Department of Administrative Services.

The tables below summarize each of the 13 veterans' organizations' subsidy line items in terms of actual FY 2018 expenditures through FY 2022 and FY 2023 appropriations.
